Mercy Law Resource Centre and the Simon Communities in Ireland invite you to our seminar, A Right to Housing.

- Date: Thursday, July 13th, 2017
- Time: 10.00am - 2.00pm
- Venue: Emmet Theatre, Trinity Conference Centre, Trinity College Dublin.

Our housing sector is in crisis with devastating consequences on the lives of hundreds of thousands of people. We must re-write the rules and fundamentally rethink our approach to housing in Ireland.

At the core of that, acting as an anchor, I believe we need to enshrine a constitutional right in Bunreacht na hÉireann. In 2014, 84% of members of the Convention on the Constitution voted in favour of enumerating such a right.

This seminar will bring together key stakeholders to outline the importance of a constitutional right to housing and to map out the next steps that could be taken, working collectively, to advance the right to housing from a policy, legislative and constitutional perspective.

Department of Justice and Equality Equality Division Call for proposals – Roma Inclusion

The Department of Justice and Equality invites applications for project proposals that will support integrated approaches to addressing the multidimensional issues faced by Roma communities living in Ireland. Proposed interventions should particularly focus on the thematic areas of Education, Cultural Identity and the Roma Community within the recently launched National Traveller and Roma Inclusion Strategy. Proposals must also promote the inclusion of both the Roma community and relevant national stakeholders in all aspects of development, implementation and evaluation.

Establishment of a National Traveller Mental Health Network

Reminder : There are still some places available to attend this discussion group. If you want your local group/organisation represented please reply at your earliest convenience.

Please note that the 2017 Mental Health Operational Plan that is being rolled out aims to employ 9 mental health coordinators specifically for the Traveller community.

This will inform part of our discussion.

The Traveller Counselling Service would like to invite you to a discussion on the establishment of a National Traveller Mental Health Network.

The aim of this network would be to;

- identify the key issues affecting Travellers mental health
- ensure a co-ordinated response to Travellers needs in terms of mental health
- advocate and lobby on issues relating to Travellers mental health
- support local groups in terms of dealing with mental health

However, on the day, other issues may be brought to the discussion that will become part of the remit of this network.

The rationale behind the setting up of this network, is that mental health is a major issue for Travellers – the situation has in fact been described as a mental health crisis within the community. Feedback from our conference in October 2016, tells us that the Traveller community and the local Traveller organisations

are struggling to deal with this mental health crisis with many projects struggling to address these issues at both a local and a national level. This difficulty is in part due to the lack of a co-ordinated response from the various organisations that work to address these. The aim of this network is to ensure that a collective and cohesive response to address mental health is in place. We hope that this discussion will generate the start of this process.

This discussion is open to Travellers and Traveller organisations engaged in addressing mental health issues within the Traveller community. There is a limited number of places available for this event due to venue restrictions (50 max).
