## [ITM Accommodation Update](#)

### **NTACC**

As members will be aware the NTACC met on the 28th of August to discuss the, Review of the Traveller Accommodation Act 98, and how best to advise the Minister on this process. It was decided to advise the Minister that an independent expert group be established to oversee the review of the Act and Traveller Accommodation in general. The expert group will consist of four experts from a legal, social policy, human rights background, and an expert at a European level. The first task of the expert group will be to review the current Review of Traveller Accommodation funding and provision of Traveller Specific Accommodation from 2000 to date which was an action from the states Rebuilding Ireland Strategy. This research has yet to be published but once

ITM is in a position to circulate this document to our members we will do so. After the expert group has reviewed the Research they will then be tasked to consult with all relevant stakeholders via written and oral form after which they will advise the Minister of the next steps needed.

The three Traveller Representatives will be forwarding our nominees of experts for this group this week to the Chair of the NTACC who will then advise the Minister on this matter. The Minister will then select members for the Expert group. ITM will keep our members updated on this matter as we receive updates ourselves. ### **NTACC Cluster Meeting:**

The next NTACC Cluster Meeting will take place in Cork City on the 13th of November. It will take in LTACCS from Cork, Kerry and Limerick. Each LTACC will be asked to give a collective presentation to the NTACC based on Best Practice on the operation of the LTACC and the provision of Traveller Specific Accommodation in their area along with what is not working well with both local and national solutions to address these issues. An Invitation letter will issue shortly to all LTACC chairs in the region seeking them to arrange a LTACC meeting to discuss and develop the collective presentation. . ITM will be linking in with our members in this region very shortly.

## **The National Plan for Equity of Access to Higher Education 2015-2019**

Programme for Access to Higher Education (PATH) Fund

### Background

The National Plan for Equity of Access to Higher Education 2015-2019 ('National Access Plan') was published in December 2015. The overall vision informing the goals, objectives and actions of the Plan is to ensure that the student body entering, participating in and completing higher education at all levels reflects the diversity and social mix of Ireland's population.

The National Access Plan contains a number of targets to increase participation by specific categories of students. Target groups include entrants from under-represented socio-economic groups and communities; entrants with disabilities; mature entrants; members of the Irish Traveller community; students entering on the basis of a further education award; and part-time flexible learners.

The implementation of the National Access Plan is an integral part of the overall

reform and landscape changes being progressed as part of the National Strategy for Higher Education to 2030.

Subsequent to the launch of the National Access Plan, the Department of Education and Skills (DES) established the Programme for Access to Higher Education (PATH) Fund. This Fund comprises dedicated funding to support access to higher education, which is allocated on a competitive basis to higher education institutions to support particular priority areas as determined by the DES.

Funding of €2.4m was made available in April 2017 for widening access to initial teacher education under

- Bursaries may be provided to full- or part-time students. It is expected that a number of the bursaries will be provided to students studying on a part-time basis.
- Bursaries will be available to undergraduates who are progressing to higher education for the first time and to undergraduate students who are currently in the system.
- Students must be attending a full-time or part-time course that meets the guidelines of the fund. Courses attended must be an undergraduate course in a publicly funded institution that: (a) takes not less than two years to complete, and (b) on the successful completion of which a student is awarded a major higher education and training award at level 6 or above on the National Framework of Qualifications.

The following conditions will also apply:

- Each bursary will be in the amount of €5,000 per annum. This applies to both full and part-time students.
- Bursaries may be approved for study across all disciplines. There will be no restriction on programme of study.
- Students are not entitled to receive the 1916 Bursary in conjunction with any other bursary or scholarship.
- Students will be entitled to hold the 1916 Bursary and the student grant simultaneously, where they meet the eligibility conditions of the student grant scheme. The 1916 Bursary will be an income disregard for the purposes of 'reckonable income' in the student grant scheme.
- It will be a condition of funding that necessary data sharing arrangements are in place, subject to data protection considerations.

- A bursary will be awarded for the normal duration of an undergraduate programme, subject to continued compliance with the bursary guidelines.

Funding will be initially provided for the award of 200 bursaries in each of the next 3 academic years, commencing in 2018/19. Continuation of the scheme, for new bursary awards, will be subject to review in Year 3. Existing bursary holders will continue to be eligible to receive their bursary for the duration of their undergraduate programme, subject to their continued compliance with the bursary guidelines.

Funding for the bursaries will be distributed through HEI Regional Clusters on the basis of a competitive call for proposals (PATH 2).

- Entrants from socio-economic groups that have low participation in higher education.
- First time, mature student entrants
- Students with disabilities.
- Part-time/flexible learners.
- Further education award holders.
- Irish Travellers

Proposals will also be expected to target the sub groups mentioned in the National Access Plan: namely, lone parents and ethnic minorities (including recently arrived programme refugees). At least 10% of all places should be targeted at lone parents.

## **Wired FM Limerick are running a media course for marginalised groups**

Ray Burke here from Wired FM in Limerick. I don't know if you have heard of us, but we're the student station in Limerick City, we're fully licensed by the BAI,

and broadcast on 99.9FM here in the city.

Wired FM are running a media course for marginalised groups in September this year, and I thought you might know people living in Limerick that would like to take part, or if maybe recommend people to get in touch with?

The course is specially tailored for marginalised groups, and specifically Travellers. No prior knowledge of the media is required, and it is suitable for any level of education, or literacy. It is open to anyone from the travelling community over sixteen, and would suit both young and old participants. The course will be held in our studios at Mary Immaculate College and a multi-media classroom at MIC.

Participants will get to learn in a fun and friendly atmosphere, and explore how radio and TV shapes the world we live in. In a group, they will make a radio programme that represents them, and advocates for changes they would like to see happen.

That course begins in early September, it runs from the September 8th to October 20th (no class Sep 29th). The closing date for applications is the 1st of September. Over six Fridays trainees will learn how the media works and get involved in radio that represents and advocates for them. Overall the classes are about empowering the participants, and building communication skills.
